**STATEMENT OF CLAIM**

TO THE DEFENDANT

A LEGAL PROCEEDING HAS BEEN COMMENCED AGAINST YOU by the Plaintiff. The Claim made against you is set out in the following pages.

IF YOU WISH TO DEFEND THIS PROCEEDING, you or an Ontario lawyer acting for you must prepare a Statement of Defence in Form 18A prescribed by the Rules of Civil Procedure, serve it on the Plaintiff's lawyer or, where the Plaintiff does not have a lawyer, serve it on the Plaintiff, and file it, with proof of service in this court office, WITHIN TWENTY DAYS after this Statement of Claim is served on you, if you are served in Ontario.

If you are served in another province or territory of Canada or in the United States of America, the period for serving and filing your Statement of Defence is forty days. If you are served outside Canada and the United States of America, the period is sixty days.

Instead of serving and filing a Statement of Defence, you may serve and file a Notice of Intent to Defend in Form 18B prescribed by the Rules of Civil Procedure. This will entitle you to ten more days within which to serve and file your Statement of Defence.

IF YOU FAIL TO DEFEND THIS PROCEEDING, JUDGMENT MAY BE GIVEN AGAINST YOU IN YOUR ABSENCE AND WITHOUT FURTHER NOTICE TO YOU. IF YOU WISH TO DEFEND THIS PROCEEDING BUT ARE UNABLE TO PAY LEGAL FEES, LEGAL AID MAY BE AVAILABLE TO YOU BY CONTACTING A LOCAL LEGAL AID OFFICE.

TAKE NOTICE: THIS ACTION WILL AUTOMATICALLY BE DISMISSED if it has not been set down for trial or terminated by any means within five years after the action was commenced unless otherwise ordered by the court.

## CLAIM

1. The Plaintiff claims:

- a) Damages in the sum of \$1,000,000 for defamation, and common law harassment, intimidation, and persecution, and invasion of privacy all by means of the making, creating, publishing and posting on the internet or the world wide web malicious and false words, postings, statements, photos, blogs, videos comments, pins and depictions (hereinafter the “Offending Statements”);
- b) Punitive, exemplary and aggravated damages in the sum of \$100,000;
- c) A Declaration and Judgment accordingly that that the defendant Zachary McQuaid is the maker, author, creator, disseminator, publisher and re-publisher directly or indirectly of the statements, postings blogs, tweets, webpages, comments, opinions, photographs, depictions and YouTube videos set out in Schedule A attached hereto (hereinafter the Offending Statements) as against the plaintiff
- d) A Declaration and Judgment accordingly that each of the Offending Statements are defamatory and constitute false, malicious, salacious, outrageous and malevolent defamation of the Plaintiff;
- e) An interim, interlocutory and permanent injunction that the defendant either directly or indirectly, including through his agents, servants, or otherwise, whether by or in his own name, or by pseudonym, nickname, alias, anonymously, or in the name of another person, and whether identified by address, photograph, or other means of identity that he has used or may use in the future, is hereby restrained, enjoined and prevented from:
  - i) making, creating, posting, publishing or republishing by hyperlink or otherwise on any website, electronic medium or platform. any statements, postings, blogs,

tweets, chats, webpages, comments, opinions, photographs, depictions of any kind or nature including videos that refers to , comments on, are about, or are concerned in any way with the plaintiff by

- ii) Assuming the identity of the plaintiff for any purpose;
- iii) impersonating the plaintiff as the author of content or a message on the internet;
- iv) taking, appropriating, or using any content, photograph, or depiction that may be found on line in respect of the social media that belongs to the plaintiff;
- v) disclosing, communicating, discussing or referring to any facts relating the plaintiff;
- vi) engaging in any form of communication that is offensive, indecent, or obscene of the plaintiff;
- vii) making of any allegations of fact, reputation or character of the plaintiff;
- viii) engaging in any form of internet communication that defames, denigrates or humiliates the plaintiff or is intended to do so;
- ix) manipulating, plagiarizing, editing, altering, or changing on line reports, news stories, comments, editorials or content so as to refer to the plaintiff;

d) An interim, interlocutory and permanent Order that the defendant is hereby restrained, enjoined and prevented from engaging in any form of act, deed, conduct or

communication, electronic or otherwise which has the effect of threatening, bullying, stalking, harassing, vexing or molesting (collectively *Harassment*) of the plaintiff. For the purposes of this Order, and without limiting the generality of the foregoing, an act, deed, conduct, or communication shall be deemed to constitute Harassment, where the same causes or is reasonably likely to cause harm to the plaintiff's health, well-being, and sense of physical or emotional security or has the effect of or may have the effect inducing or causing fear for his safety, privacy and security. Without limiting the generality of the foregoing, Harassment shall be deemed to include:

- i) disclosure of sensitive personal facts or breach of confidence relating to the plaintiff;
- ii) any act or conduct which is threatening, intimidating or menacing of the plaintiff;
- iii) any form of communication that is offensive, indecent, or obscene the plaintiff;
- iv) any form of electronic or non electronic form of communication that makes false allegations of the plaintiff;
- v) communications of any nature including video communication that incites or encourages another person to commit harass or vex the plaintiff;
- vi) communications that denigrates or humiliates the plaintiff or is intended to do so;
- vii) attending or entering any premises or property where the plaintiff works, lives, or conducts his affairs;

- viii) manipulating, plagiarizing, editing, altering, or changing on line reports, news stories, comments, editorials or content so as to refer to the plaintiff;
- e) A Declaration and Judgment accordingly that the publication of the Offending Statements constitutes harassment of the plaintiff;
- f) An Order that the plaintiff may, at his sole discretion take all reasonable actions to remove or cause to be removed the Offending Statements as listed in Schedule A from the Internet and may, at his sole discretion, request that all Internet engines including but not limited to Google; Yahoo!; Bing; duckduckgo.com; ecosia.org; gigablast.com; qwant.com; comsogou.com; startpage.com; comwebcrawler.com; yandex.com together with their search indices all of the URLs listed in Schedule A to this Judgment;
- g) An Order in the nature of Mandamus or mandatory order that the defendant forthwith remove or cause to be removed the Offending Statements as listed in Schedule A from any website or page on the Internet together with any and all additional webpages that reference and/or hyperlink to the Offending Statements including removal from the Internet search engines as set out above of all such Offending Posts, such removal to occur under the supervision of the Court by an *amicus curiae*, independent supervising solicitor, or an expert appointed by the Court for such purpose;
- h) An Order that upon the want of compliance by the defendant with the relief sought in this proceeding that the right, title, interest and ownership of the defendant in the Offending Statements, be and the same be transferred, without recourse, to such *amicus curiae*, independent supervising solicitor or expert so appointed by the Court in order to perform the removal of the Offending Statements listed in Schedule A;

- i) An Order that the benefits, effect and remedies afforded by the Judgment shall be and is hereby extended to any and all the past present and future partners, professional corporations, partnerships, employees, employers, associates, family trusts, family members, and persons related to or associated with the plaintiff;
- j) An Order in the nature of mandamus or mandatory Order that the Defendant shall issue forthwith to the plaintiff an apology and retraction upon the issue and entry of any judgment in written form and signed by him and addressed to the plaintiff (*Apology and Retraction*).

The Apology and Retraction shall be in the following form:

*I Zachary McQuaid OF THE CITY OF TORONTO, DO HEREBY APOLOGIZE TO GABRIEL ALAN HOFFMAN FOR THE ON LINE DEFAMATORY, AND FALSE STATEMENTS THAT I HAVE BEEN FOUND TO HAVE MADE BY THE ONTARIO COURT AND I HEREBY UNRESERVEDLY RETRACT SUCH STATEMENTS AND EXPRESS REGRET FOR THE HARM AND INCONVENIENCE THAT I MAY HAVE CAUSED HIM.*

- k) An Order that the plaintiff is at liberty to publish the Apology and Retraction the Internet and is at liberty to publish, provide or deliver them as he deems fit and necessary so as to protect his reputations and to draw to the attention of the public the effect of the judgment of this Court;
- l) An Order by way of mandamus that the defendant deliver forthwith to the plaintiff or as the court may direct all Gravatar and all other login credentials (user id and passwords) for web sites on which he has created posts and videos as against the plaintiff;
- m) Costs of this action on a full indemnity basis;
- n) All taxes where applicable;

o) Such further and other relief as to this Court may deem just.

### **The Plaintiff and the Defendant**

2. Plaintiff Gabriel Alan Hoffman is an individual and is a resident of Palm Beach County, Florida. The plaintiff is the founder of Accipiter Capital Management, LLC. (“Company”) which is a hedge fund, located in Palm Beach County, Florida. The plaintiff is a highly respected and well known investment manager who regularly appears on television addressing a wide range of business issues and financial investments. As such the plaintiff’s livelihood and success are inextricably connected to his unassailable integrity and hard-won relationships with his investors. The plaintiff maintains relationships with prominent and well-known individuals in the financial markets and financial management industry and relies on his excellent reputation and unassailable integrity to attract and maintain his investment capital for his Company’s operations. In addition, the plaintiff is a well-respected philanthropist, who solely funded and produced the groundbreaking documentary film exposing child sex abuse in Hollywood, “An Open Secret”. “An Open Secret” has generated extensive worldwide press and critical acclaim, by many major publications, television, and widely viewed forms of alternative media. Two years ago, the plaintiff released his \$1.5 million budget documentary film free to the public on Vimeo.
3. The plaintiff says and the fact is that the film immediately went viral, has been watched by many millions of people worldwide, and has been publicly endorsed by numerous film critics, celebrities, and many other notable people. Millions of people have seen the plaintiff in live interviews, or in print / internet media worldwide, discussing his film.



4. The defendant is an individual residing in the City of Toronto. He is of limited or no financial means and education and has a self professed history of mental illness. Regardless, the defendant is one of a circle of individuals in the United States and Canada who engage in the on line exchange of “conspiracy” theories and related commentary. In so doing, the defendant has intentionally seen fit to target the plaintiff with defamatory on line comments, posts, videos and other content with the intention of lowering the plaintiff’s reputation and harassing the plaintiff.

### **Background to This Action**

5. On October 11, 2019 the plaintiff found that a tweet had been posted at the Twitter account for the plaintiff’s film, An Open Secret. The tweet was from an anonymously-named Internet account, the owner of which was unknown to the plaintiff at that time: @stepho\_11. can be found at:

6. This tweet was posted in reply to the film’s Twitter account @anopensecret as follows:

“Hey Hoffman, did you order a hit on Isaac? You act like a psychopath!”

7. At that time, the plaintiff blocked the user from both the Twitter account for the film, as well as his personal Twitter @gabehoff.
8. On November 7, 2019 the plaintiff first became aware that the defendant was the maker author and poster of a number of defamatory videos by monitoring the social media of Thomas Schoenberger, an individual against whom the plaintiff had filed a defamation lawsuit on October 28, 2019 in the United States. The social media contained a link to a YouTube video posted at 5:27 PM on Nov. 7 2019. The video is found at:

9. The video contains a defamatory statement, approximately 1:15 into the video. It reads: “Gabe Hoffman – Jewish terrorist a chief suspect in the murder of Isaac Kappy”. At the video’s conclusion a link to a PayPal account was advertised, requesting donations.
  
10. The plaintiff then discovered that the same user had also created 5 other videos, on October 13, October 20, November 3, and November 6, 2019.
  
11. The plaintiff then discovered that the defendant maintains a YouTube channel, titled “Zack Quaid”, and found his email address, which had been posted publicly as [zackmcquaid2015@gmail.com](mailto:zackmcquaid2015@gmail.com), which contained his actual full name.
  
12. The plaintiff also then discovered on Thomas Schoenberger’s Twitter feed a November 6, 2019 tweet at 7:18PM, replying to @stepho\_11 “good work Zach”, in response to the account @stepho\_11 posting a link to another defamatory video created on the same YouTube channel, “Isaac Kappy’s Real Deadman’s Switch”, this is found at:

13. The plaintiff also found a tweet at 4:45 PM Nov 6, 2019 to the defendant on his @stepho\_11 account, instructing McQuaid to set up a PayPal account, to receive donations, ostensibly in return for McQuaid's creation of defamatory YouTube videos about the plaintiff as follows:

“That is a hell of a video. Set up a PayPal account, people will donate. You are really talented!”

14. Contained in the defendant's twitter account @stepho\_11, was a reference to the defendant's admission of a history of mental illness. The Mental illness documentation is found at:

15. On Friday November 8, 2019 the plaintiff wrote an email to the defendant as follows:

“Zack, I am willing to speak with you about what is going on. Dialogue never hurts. Let's schedule a conversation, a day and time, on Google Hangouts”. Gabe Hoffman

16. The defendant answered at 8:29 PM on Friday November 8, and his response demonstrated that dialogue about his defamatory videos was out of the question

“Hi Gabe...no. I know what is going on and I already know you know that my relative is an active FBI agent. You are getting screwed by Defango behind your back... He is recording your convo's for Feds..... Think I am kidding?... Go ask Priest to hire one of his china hackers. Friction between Brett and Cory as well. It's falling apart. Good luck. God bless you.”

17. The plaintiff also attempted to contact a family member of McQuaid, to inform them of his actions. On Nov. 8, 2019 the plaintiff sent Terri McQuaid, a Facebook message on which contained a description of Zachary's actions, a link to his Twitter profile @stepho\_11, and a link to a defamatory video McCquaid produced on his YouTube channel. Mrs. McQuaid responded on the morning of Nov. 12, 2019 and her initial response included the statement:

“Zach has serious mental health issues... I'm overwhelmed by it all. Please give me an hour or so and I'll get myself prepared for what I am possibly going to see.”

18. On the morning of November 13, 2019 the plaintiff sent Mrs. McQuaid a link to a newly-created video by the defendant, concerning a video he made on the evening of November 12. The video is “I am being hunted” in Schedule A. At about 20 seconds into the video, the false and defamatory claim is made that the plaintiff “he has now started to stalk my family” and “he contacted my mother and attempted to frighten her...” At 44 seconds the video states “Gabe Hoffman is a Jewish terrorist operating on American soil”. The video contained a disturbing image of a ring of fire.

19. The plaintiff says that after November 8, he began to regularly check the defendant's YouTube channel every few days. Notwithstanding the plaintiff's attempts to compel a retraction of the offending internet material and notwithstanding appeals to the defendant's family, the defamatory campaign of the defendant of the plaintiff continued.
20. The plaintiff says that has severely curtailed his ability to spend time on social life, exercise, and hobbies, outside of the substantial and challenging work requirements of his job as an investment manager. The defendant's campaign and internet defamation and harassment has left him depressed, shocked, and troubled.
21. As of the date of this pleading, the defendant has posted over 25 defamatory tweets and over 25 defamatory videos in a period of just over a month.
22. As of Dec 10, 2019, one of the defendant's 2 YouTube channels has had nearly 37,000 views, the overwhelming majority of which are derived from views of videos which specifically and repeatedly defame him personally. These videos falsely label the plaintiff as a "Jewish terrorist"; falsely accuse him of murder-for-hire, stalking, and many other serious crimes.
23. McQuaid's defamatory videos have been promoted by other individuals defaming the plaintiff on the Internet, particularly Thomas Schoenberger, against whom the plaintiff had filed a defamation lawsuit on October 28, 2019.
24. In addition, the defendant's defamatory videos have also been posted, and promoted, by individuals with significantly larger media platforms, which has added greatly to the plaintiff's emotional distress.

25. For example, the defendant has created a defamatory video of Nov 6 “Isaac Kappy’s Real Deadman Switch”, in which the plaintiff is falsely defamed as follows 8 “he knows the mob is looking at him and saying ‘Bubbie, you are drawing way too much attention to us’ “and “Gabe Hoffman is a gatekeeper and was ordered to attack Isaac by Steven Spielberg & other heavy hitters in Hollywood”.

26. The defendant’s extremely defamatory video by McQuaid has been posted and promoted by Steve Outtrim, a New Zealand millionaire, on both his twitter account @steveouttrim, which has over 6,500 followers, and his twitter account @burnersdotme, which has over 15,000 followers. This video was also repeatedly been linked on Outtrim’s website “burners.me”, a website that receives substantial web traffic.

27. Media has described Outtrim’s burners.me website as “The Fox News of Burning Man”, a label which Outtrim heartily embraced.

28. Burning Man receives regular and widespread coverage in American pop culture, television, film, and news reports. [https://en.wikipedia.org/wiki/Burning\\_Man](https://en.wikipedia.org/wiki/Burning_Man)

“**Burning Man** is an event held annually in the western United States at Black Rock City, a temporary city erected in the Black Rock Desert of northwest Nevada, approximately 100 miles (160 km) north-northeast of Reno, and a thriving year-round culture generated by a global community of participants.”

Roughly 70,000 participants travel to a remote location in Nevada for a week.

29. McQuaid's defamatory videos have also been repeatedly copied from his YouTube channel, and re-posted by others who seek to defame him.

30. Thus, the continued availability of McQuaid's many defamatory videos on his YouTube channels, particularly the copying and re-posting of McQuaid's defamatory videos by others, represents a clear, growing, and irreparable harm to the plaintiff's reputation and sense of security.

### **The Threat of Personal and Physical Harm**

31. The plaintiffs say and the fact is that the internet communications created, authored, and posted by the defendant has exposed the plaintiff and his family to personal risk and physical harm by internet vigilantes and hackers. Unless properly restrained by this Honourable Court, the defendant will continue his on going vicious attacks.

### **Particulars of Postings**

32. Particulars of some of the postings discovered to date as they affect the plaintiff in this Action are set out in Schedule A.

33. The plaintiff says and the fact is that the above defamatory posts are easily accessible on the internet and come up on search engines when searching the plaintiff by name. The said posts falsely accuse the plaintiff as being *inter alia* a terrorist, a murderer, a stalker, and one who attacks victims of pedophile attacks.

34. The plaintiff says that the said statements in their entirety and in their context are false, incapable of justification, and defamatory of the plaintiff. The defendant refers to the plaintiff by name and includes photos of him with further defamatory statements written on the photos. The sole purpose of the statements is to defame, disparage, and ruin the plaintiff's reputation.

35. The plaintiff says that the defendant published the statements with malice knowing that they were false, or with reckless disregard as to whether there were true or not. The defendant published the statements maliciously in that he had some improper and ulterior motive in publishing them.

36. Particulars of the defendant's malice include:

- a) He had no honest belief in the false and defamatory information contained in the statements because he knew or ought to have known the defamatory information was false and fabricated;
- b) He had a reckless disregard for the truth in what he published in the defamatory statements because he took no steps to properly verify the truth of the information;
- c) He has not published any apology or retraction to the plaintiff.

### **Damages**

37. The plaintiff says and the fact is that the statements have impugned the professional and personal reputation and integrity and character of the plaintiff. The plaintiff has suffered unnecessary personal embarrassment, humiliation, anxiety, and distress as a result.

### **Aggravated and Punitive Damages**

38. The malicious and high handed callous and arrogant conduct of the defendant in publishing the defamatory statements displays a wanton and flagrant disregard for the plaintiff's rights. The



defendant has acted in a premeditated and calculated manner and has deliberately and maliciously defamed the plaintiff.

39. In the circumstances, the defendant is liable to the plaintiff for aggravated and punitive damages.

### **Interim, Interlocutory and Permanent Injunctions**

40. The plaintiff says that he has a prima facie case of defamation as against the defendant and will suffer irreparable harm if he is not restrained from continuing to publish defamatory statements about the plaintiff and if he is not ordered to remove all such statements already published. The balance of convenience favors the granting of the interim, interlocutory and permanent relief sought.

41. The plaintiff says that a permanent injunction is an appropriate remedy once this action has been adjudicated as future damages for defamation will be difficult to quantify and damage to reputation cannot be satisfactorily repaired with an award of damages

### **Harassment**

42. The plaintiff says further that the defendant has acted in a manner designed to molest, vex, harry and harass the plaintiff for improper or collateral purposes by engaging in on going internet based defamation.

43. Although not required by the law off Ontario to do so, the plaintiff has served a Notice of Intended Action pursuant to section 5 of the *Libel and Standards Act*.

44. The plaintiffs plead that this Action be held in the City of Toronto.
