**AFFIDAVIT OF GABE HOFFMAN IN SUPPORT OF**  
**MOTION FOR INJUNCTIVE RELIEF**

1. My name is Gabe Hoffman. I submit this Affidavit in support of my Motion for Injunctive Relief in connection with the above-litigation involving Julio Cesareo Jacquez ("JACQUEZ").

2. The documents attached as Exhibits to this Affidavit are true and accurate copies and I authenticate them as part of my Affidavit.

3. I am the founder of Accipiter Capital Management, LLC, ("Company") which is a hedge fund, located in Palm Beach County, Florida.

4. I am a highly respected investment manager who has previously appeared on television addressing a wide range of business issues and financial investments.

5. My livelihood and success are inextricably connected to his unassailable integrity and hard-won relationships with his investors.

6. I maintain relationships with prominent and well-known individuals in the financial markets and financial management industry and relies on my excellent reputation and

unassailable integrity to attract and maintain investment capital for my Company's operations.

7. I am a well-respected philanthropist who individually and solely funded and produced a ground-breaking documentary film exposing child sexual abuse in Hollywood titled "An Open Secret."

8. "An Open Secret" has generated extensive worldwide press and critical acclaim by many major publications, television and widely viewed forms of alternative media.

9. Millions of viewers have seen me discussing "An Open Secret" and child sexual abuse in Hollywood in live interviews, or in print/internet media throughout the world.

10. A former Hollywood bit actor named Isaac Kappy gained notoriety through his public accusations of pedophilia, which included accusations against prominent Hollywood personalities of the Jewish faith, such as Seth Green and Steven Spielberg.

11. As a result of my documentary on child sexual abuse in Hollywood and as a result of my Jewish faith, I have become a target of Kappy's baseless allegations of pedophilia in Hollywood.

12. Kappy was found dead on Monday, May 13, 2019, at the age of 42. His death was reported in local newspapers as a suicide, which cited a statement from the Arizona Department of Public Safety. Kappy jumped to his death at the Transwestern Road Bridge near Bellemont, Arizona, and was struck by a pickup truck on Interstate 40, around 7:30 AM. <https://www.azcentral.com/story/news/local/arizona-breaking/2019/05/15/thor-actor-isaac-kappy-jumps-off-arizona-bridge-near-flagstaff/3682802002/>. 13. Kappy's death became the subject of speculation on various social media sites on the internet. Various extreme and outlandish conspiracy theories attempted to link me, as well as

certain Hollywood celebrities to Kappy's death, positing that Kappy was murdered, rather than died by suicide.

14. Kappy was an ardent believer in the QAnon conspiracy theory. QAnon has been described in the media as "a baseless conspiracy theory that a shadow network is working against President Trump, and that an insider, "Q," knows how it will be exposed." <https://www.buzzfeednews.com/article/briannasacks/fbi-memo-conspiracy-theories-domestic-terrorism>. See **Exhibit "2"** attached hereto.

15. Kappy's final post on Instagram, prior to his suicide, featured an apology to QAnon, <https://www.theblaze.com/news/actor-leaves-apology-to-trump-before-killing-himself>. See **Exhibit "3"** attached hereto.

16. In a May 30, 2019, memo obtained by Yahoo news, the F.B.I. office also describes how QAnon theorists believe that Trump is leading an effort "to dismantle a conspiracy involving 'deep state' actors and global elites allegedly engaged in an international child sex trafficking ring."

17. The F.B.I. memo also states that federal authorities believe "identity based, and fringe political conspiracy theories", such as QAnon, are very likely to motivate some domestic terrorists to "commit criminal and sometimes violent activity," since certain narratives "tacitly support or legitimize violent action." <https://news.yahoo.com/fbi-documents-conspiracy-theories-terrorism-160000507.html>. See **Exhibit "4"** attached hereto.

18. The United States Secret Service does not allow people displaying "QAnon" to enter Trump rallies. <https://www.thedailybeast.com/qanoners-say-their-qanon-merch-is-being-banned-by-secret-service-at-trump-rallies>. See **Exhibit "5"** attached hereto.

19. The media has also reported that a QAnon follower murdered a reputed New York

City mob boss in July, 2019. <https://abcnews.go.com/US/man-shot-mob-boss-francesco-franky-boy-cali/story?id=64483955>. See Exhibit "6" attached hereto.

20. JACQUEZ has defamed me numerous times accusing me of being part of an imagined "Jewish mob," and having murdered Isaac Kappy.

21. JACQUEZ has publicly expressed his belief in the QAnon conspiracy theory through many social media posts and YouTube videos he created.

22. JACQUEZ has also expressed his belief in various other baseless conspiracy theories, publicly, on his YouTube channel:

- a. JACQUEZ created a video on his YouTube channel on October 28, 2019, titled "MORE EVIDENCE OBAMA WAS LYNCHED OR HUNG OR PUT TO DEATH LIKE A DIRTY DOG! TO GOD GOES ALL THE GLORY!"

- b. JACQUEZ created a video on his YouTube channel on October 26, 2019, titled Obama Hanged For Treason and Trump Celebrates by tweeting what he can to those woke enough to read! <https://www.youtube.com/watch?v=gSmW0ShbbiY&feature=youtu.be&fbclid=IwAR04WELf1JsCCUq-C2osBo7zmyaVG14doPd5Ru7sLMrOkbQishD6Xpd4Bg>.
- c. JACQUEZ created a video on his YouTube channel on November 2, 2019, titled "Trump Told Everyone Obama was executed!"  
[https://www.youtube.com/watch?v=8O8cof-vr\\_Y](https://www.youtube.com/watch?v=8O8cof-vr_Y).
- d. JACQUEZ created a video on his YouTube channel on December 14, 2019, asserting that Hillary Clinton (as well as Barack Obama) is dead, and that a "clone" or a "body double" is walking around with her husband Bill Clinton. The caption underneath the video states "Hillary Clinton Body Double or Clone is so obviously not her! She was Executed for

Treason!" [https://www.youtube.com/watch?v=oTY9Y856b\\_I](https://www.youtube.com/watch?v=oTY9Y856b_I).

23. JACQUEZ has also posted memes on social media which promote hatred against the Jewish people. JACQUEZ posted a meme on his Facebook page, under the handle "Julio Hawkes", stating "follow the money", with a Jewish star made out of dollar bills <http://archive.is/wkCc3>.

24. In light of this background, JACQUEZ has published numerous defamatory statements on Twitter, as well as his YouTube channel "An All America Cartel, LLC", accusing me of being involved in Kappy's imagined murder.

25. JACQUEZ published reprehensible and defamatory statements in YouTube videos, which he created on his YouTube channel, "An All American Cartel, LLC."

26. JACQUEZ also promoted these reprehensible and defamatory videos, on Twitter, posting links, on 12 documented occasions, under the handle of @infinitytozero, and two documented occasions on his Facebook page, under the handle "Julio Hawkes."

27. Twitter and YouTube are available in the state of Florida, and therefore statements published on Twitter are published to the public at large in the state of Florida.

28. JACQUEZ created a YouTube video, titled "Breaking News on Isaac Kappy Murder. Velvet Mafia? What is Gabe Hoffman Hiding? We need answers" (October 14, 2019), in which JACQUEZ placed, and displayed defamatory text, which included the following:

- a. ""@gabehoff He is a pedo protector, He hides most of his funds in the Caymans. It's the Jew money from Hollywood porno outfits and it includes child porn."
- b. "It's a total Jewish mob fraud. His company Accipiter was started by Moshin Meghj. The money was provided by Leslie H. Wexner, of Victoria's Secret fame. Gabe knew Jeffrey Epstein well, and has been to the island dozens of times. He

bought his boyfriend and they enjoyed being tied up and having 16 year old boys piss on them. Gabe met Richard on a Urination website on the dark web.”

- c. “Gabe had 2 surgeries for micro penis syndrome in 2012 and 2016, both at Mount Sinai Hospital in Manhattan.”
- d. “Gabe runs An Open Secret and was in a legal battle with his director after she found Gabe was covering up pedophilia by Steven Spielberg and other pedo’s. Gabe paid Unirock to present news and also Defango and Monkey Savant. Gabe is now after Thomas Shellenberger because Gabe hired the hitman who killed Kappy.”
- e. “So the murder was done by Harvey Levin and Gabe Hoffman. They paid a guy named Craig Sawyer and a guy named Daniel Ryan Doud to kidnap and then kill Kappy with an air gun with Ice bullet. Then Bart Graves did the cover up.
- f. “Defango was paid to distract and so was Eli. They blamed this schellenberger and Kate Anon and put Gabe in charge of the cover up.”
- g. “They even hired some people from fetishbank, golden showers freaks, and they hired Monkey Savant.”
- h. “They donated 5000 to Defango through magaCoalition and ignored UniRock, who Gabe dumped.”

29. JACQUEZ created a YouTube video, titled “Isaac Kappy's Alleged Murderers Craig Sawyer (pro Hollywood sniper) and Daniel Doud (probable demon)” (October 14, 2019), in which JACQUEZ displayed defamatory text, which included the following:

- a. JACQUEZ stated in the beginning of this video, “So these are the alleged murderers that my sources named, not sure, but it kind of fits.”
- b. JACQUEZ placed, and displayed, identical defamatory text in this video he



created, as is repeated in 32 (e), (f), (g), and (h).

30. JACQUEZ made defamatory statements against me in a YouTube video he created, and posted to his YouTube channel, titled "An Open Secret or Gabe Hoffman killed Isaac Kappy? Does he know who killed Kappy? Why does he care" (October 11, 2019). JACQUEZ accused me of "taking people's survivor stuff, and the real ones, you pretty much silence, quiet, or attack". JACQUEZ statement regarding "survivors", refers to survivors of child sex abuse in Hollywood, the subject of my documentary film, An Open Secret:

- a. JACQUEZ stated "Gabe Hoff. Yeah man, An Open Secret, you seem to be... I've heard lots of stuff about you, that you're taking people's, you're like a honeypot, you're taking people's survivors stuff, and the real ones, you pretty much silence, or quiet, or attack."
- b. JACQUEZ stated "Feel free to answer, feel free to sue me, feel free to kill me, feel free to, um, I don't know, curse my name to the high heavens, I don't know. Do what you gotta do, I'm protected, to G-d be the glory.... To G-d be the glory guys."

31. JACQUEZ copied and re-uploaded a YouTube video to his channel, which was originally created by Zachary McQuaid<sup>1</sup> of Canada, on October 13, 2019, which JACQUEZ re-titled "Isaac Kappy Murdered for exposing Jewish Pedophile Roots? Jewish mobsters?"

- a. The video displayed the following defamatory text: "Gabe Hoffman is an obsessed and creepy stalker. Isaac Kappy knew it. And now so do you."
- b. The video displayed the following defamatory text: "Gabe Hoffman has been tied to Jewish extremists. And is a known liar who attacks SRA and child sex abuse victims, while whiteknighting as an advocate of child abuse victims."

- c. The video displayed the following defamatory text: “Because Isaac was revealing what Gabe wanted hidden. The Jewish roots of pedophilia in Hollywood... Gabe Hoffman must be investigated for the death of Isaac Kappy.”
- d. The video concludes by displaying HOFFMAN’s image on screen, with the text “Isaac Kappy’s killer?”
- e. JACQUEZ made reference in the description for this video, to having obtained permission to re-post McQuaid's video, from Thomas Schoenberger<sup>2</sup>.  
JACQUEZ wrote “Not my video but Wyatt Earp Aka Doc Holiday aka Fat Val Kilmer said it was all Good.” Schoenberger created and operated a YouTube channel titled "Doc Holliday", prior to its termination by YouTube around December 9, 2019,” due to multiple or severe violations of YouTube’s policy prohibiting content designed to harass, bully, or threaten.”

32. JACQUEZ made defamatory statements against me, in a YouTube video he created, and posted to his YouTube channel on October 14, 2019, titled “WARNER BRO'S KILLED ISAAC KAPPY? TMZ AND BART GRAVES OWNED BY WARN A BROTHER?”

- a. JACQUEZ stated during the video: “ All right guys I figured it out. It was WB and Harvey Levine and all those other companies and I'm sure Gabe Hoffman is in there somehow we'll figure that out but Bart graves used to work for WB.”

33. JACQUEZ posted a YouTube video to his channel, on October 13, 2019, which he titled: "Gabe Hoffman Come on Down! We need you to answer some questions. Or don't."

- a. JACQUEZ stated in the video: "Gabe Hoffman, come on down. We got some questions for you, buddy. They're gonna get answered buddy. Even if I have to call your boss, your partners, your fuckin company to talk to you directly. Email me, message me. I mean, I'm gonna figure out if you're connected to Epstein, your company at least. I bet you are, you all are connected somehow I'm sure."
- b. The video concludes with the following text placed on screen: "Are you involved with Epstein? Are you Jewish? Are you protecting Pedophiles? Are you a pedophile? Were you involved with murdering Kappy? Inquiring minds want to know [anallamericantellc@gmail.com](mailto:anallamericantellc@gmail.com)"

34. JACQUEZ copied and re-uploaded a defamatory YouTube video to his channel, which was originally created by Thomas Schoenberger of California, on October 11, 2019, which JACQUEZ re-titled "Gabe Hoffman of An Open Secret is SUSPECT to many including TS and Steve Outrim"

- a. Schoenberger stated: "Gabe Hoffman is blocking, deflecting, attacking. Something is up, folks. Something is really serious here. "We need to start looking at Gabe Hoffman as a suspect, in the death of Isaac Kappy. JACQUEZ then stated "He's absolutely right, on the suspicious part of Gabe Hoffman."
- b. Video displays text stating: ""Is Gabe Hoffman complicit in the death of Isaac Kappy."

35. On or about January 4th, 2020, JACQUEZ was served the original Complaint.

36. Since being served the original Complaint, JACQUEZ has amplified the nature and frequency of his heinous and defamatory statements against me, including creating multiple

defamatory videos targeting me with violent imagery and overtones. Noteworthy aspects of the defamatory, shocking and scurrilous videos include many gunshot sounds, and the image of a person with a bag over its head and a gunshot through the eye of the person, which is displayed for 3 minutes in the video while JACQUEZ discusses me. See “Exhibit “8” attached hereto.

37. JACQUEZ’S published statements are false.

38. JACQUEZ knew these statements were false and negligently made these statements anyway.

39. I have been damaged by these statements. JACQUEZ’S statements were completely defamatory and calculated to damage my reputation as a well-respected financial manager.

40. JACQUEZ is well aware of the business relationship I have with investors and his heinous and defamatory statements were calculated to damage those existing relationships.

41. JACQUEZ’S defamatory statements were intentional and unjustified.

42. JACQUEZ, through his numerous heinous and defamatory comments has tortiously interfered with my business by damaging my professional reputation and his ability to manage investor money.

43. As outlined in this Complaint, JACQUEZ is associated with a dangerous conspiracy cult that the F.B.I has publicly warned Americans about, that the United States Secret Service will not allow into Trump rallies, and as has been reported by the media, is connected to at least one murder of a putative crime figure. There is a real and present danger to me by JACQUEZ’S QAnon following; and as matter of fact, JACQUEZ has issued a “call to arms,” so to speak, against me in some of his videos. The probability that tragedy might befall me is real and palpable given that potentially demented, misguided and mentally deranged

members of QAnon could very well take action against me.

44. To this end, I met with the Palm Beach County Sheriff's Office ("PBSO") in January, 2020, concerning the potential for JACQUEZ'S videos to incite violence against me. I provided a PBSO deputy with evidence in person, as well as via email, concerning these, and other related matters. At the recommendation of PBSO, and for similar reasons, I recently traveled to the local F.B.I. office in West Palm Beach and met with a Special Agent of the F.B.I. and provided that Special Agent with evidence in person, as well as via email, concerning the potential for videos created by JACQUEZ to incite physical harm against him, as well as other related matters.

45. This damage to professional reputation has irreparably harmed me. *Clare v. Coleman (Parent) Holdings, Inc.*, 928 So. 2d 1246, 1249 (Fla. 4th DCA 2006).

46. I have a substantial likelihood of success on the merits of its my claims against JACQUEZ.

47. I lack an adequate remedy at law.

48. Given the ugly nature of JACQUEZ'S defamatory statements and his tortious interference with my business relationships, the threat of a known terrorist group being appealed to (QAnon) for assistance and the likelihood that this terrorist group could take action against me to assist JACQUEZ in his misguided crusade against me, the public interest is served by: 1) entering a temporary and permanent injunction against JACQUEZ, restraining him from all misconduct referenced above, including the removal of every single social media, YouTube, and internet post where JACQUEZ has defamed me and, 2) enjoining JACQUEZ from traveling within five (5) miles of my residence in Palm Beach

County, Florida, if in fact JACQUEZ travels to the State of Florida to represent himself in this proceeding or for any other matter.

# 'Thor' actor Isaac Kappy dies in Arizona at age 42

Actor Isaac Kappy died Monday near Flagstaff.

Arizona Department of Public Safety officials said the 42-year-old died at the scene after jumping off the Transwestern Road bridge and onto I-40 about 7:30 a.m. The bridge is in the unincorporated Bellemont community west of Flagstaff.

DPS officials say two teenage witnesses told troopers they tried to stop Kappy.

Kappy was an actor from Albuquerque, New Mexico, and had small roles in major movies. He played the pet store clerk in the 2011 blockbuster movie "Thor." He had the role of Barbarossa in the 2009 film "Terminator Salvation" and Garfunkel in the 2009 movie "Fanboys."

Kappy also was a member of the band Monster Paws.

According to his band mate Nate Santa Maria, Isaac was strong-willed and eccentric, as well as a great producer and engineer.

Santa Maria says Kappy was part of some of the greatest musical adventures of his life.

"I'll never forget him and his great humor and genuine kindness," said Santa Maria.

"There was nobody like him and there will never be again. He is irreplaceable," said Santa Maria.

Authorities say they are investigating the incident as a suicide.

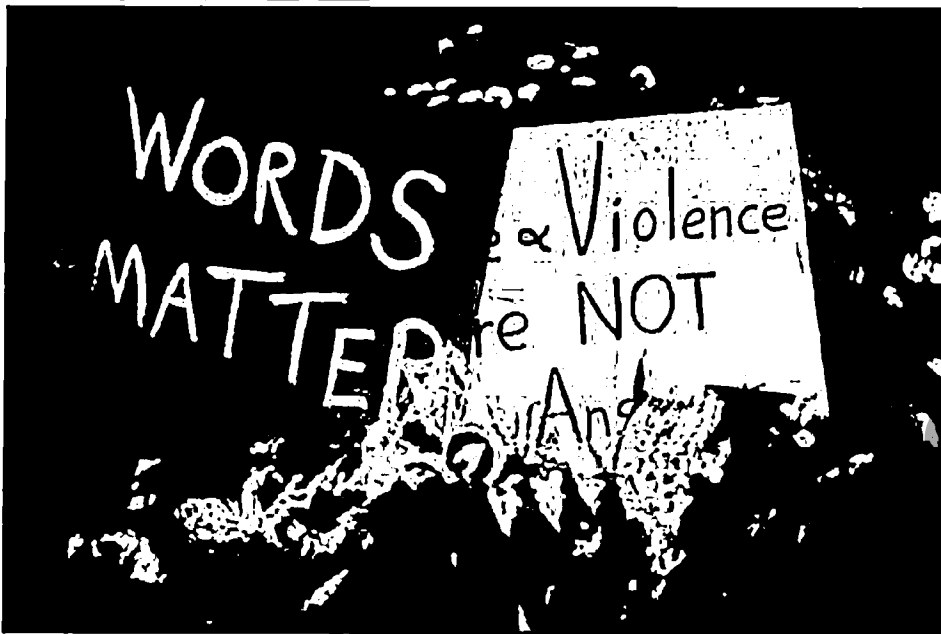

The FBI considers conspiracy theories that are born and spread online a dangerous breeding ground for domestic terrorists, according to recently revealed bulletin produced out of the agency's Phoenix field office.

The May 30 memo, first obtained by [Yahoo News](#), states that federal authorities believe "identity based, and fringe political conspiracy theories" are very likely to motivate some domestic terrorists to "commit criminal and sometimes violent activity," since certain narratives "tacitly support or legitimize violent action."

The bulletin specifically refers to QAnon, a baseless conspiracy theory that a shadow network is working against President Trump, and that an insider, "Q," knows how it will be exposed. The FBI office also describes how QAnon theorists believe that Trump is leading an effort "to dismantle a conspiracy involving 'deep state' actors and global elites allegedly engaged in an international child sex trafficking ring."

Trump supporters have embraced the conspiracy theory, wearing shirts and hats that feature the letter "Q" at his rallies.

Members of the QAnon community expressed their anger and disbelief on Twitter, exclaiming, "how can Q and POTUS let this happen?"

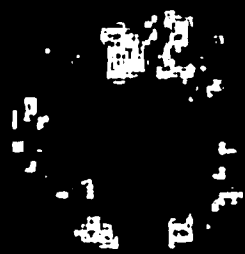

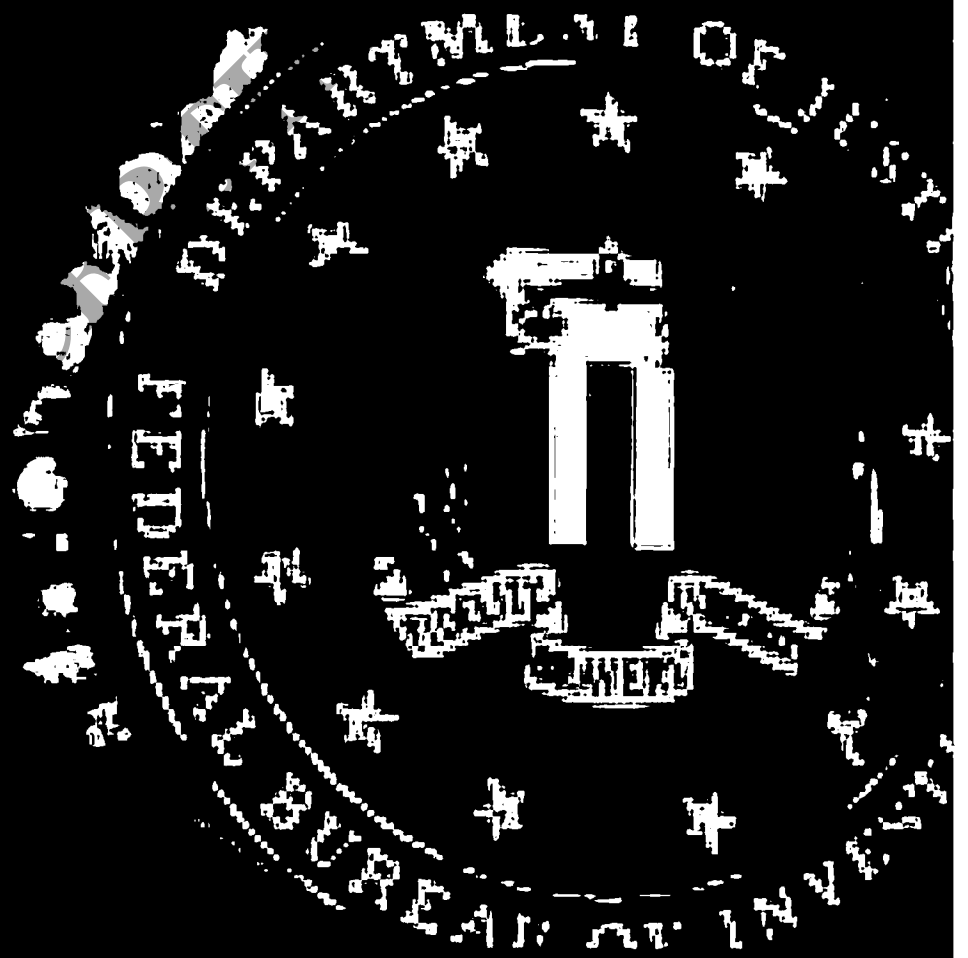

The 15-page bulletin is the “first FBI product examining the threat of conspiracy theory–driven domestic extremists” and lists instances in which suspects plotted or carried out “deadly violence” because of false, fringe theories that they had found online.

They include that a gunman who killed 11 people at the Tree of Life Synagogue shooting in Pittsburgh last October, for example, had reposted a Zionist Occupation Government conspiracy theory cartoon on social media. In June 2018, a man from Nevada decked out with body armor, rifles, and ammunition was arrested and referenced QAnon.

On Tuesday, the Daily Beast reported that Twitter suspended an account that blasted conspiracy content, including QAnon material, after the president retweeted a theory that Democrats are the ones “interfering in our elections.”

The FBI document also cites Pizzagate, the bogus theory that Democratic operatives tied to Hillary Clinton were running a child sex-trafficking ring out of a pizza restaurant in Washington, DC. In 2016, a man from North Carolina showed up to the joint with an AR-15 rifle, shot through a door, and aimed it an employee thinking he was saving trafficked children.

“The FBI assesses these conspiracy theories very likely will emerge, spread, and evolve in the modern information marketplace, occasionally driving both groups and individual extremists to carry out criminal or violent acts,” the bulletin states. “These targets are then subjected to harassment campaigns and threats by supporters of the theory, and become vulnerable to violence or other dangerous acts.”

In its bulletin, the FBI's Phoenix Division also points out that because some conspiracy theories are highly partisan, major political events like the 2020 presidential election cycle will probably produce more extremists.

Although the bulletin acknowledges that conspiracy theory-driven crime is not new, it emphasizes how "today's information environment" and "crowd-sourcing" have changed the way the content more easily spreads and evolves.

"It is logical to assume that more extremist-minded individuals will be exposed to potentially harmful conspiracy theories, accept ones that are favorable to their views and possibly carry out criminal or violent actions as a result," the document states.

When asked about the Phoenix Division's bulletin, an FBI spokesperson told BuzzFeed News that it is the agency's standard practice to "not comment on specific intelligence products."

"The FBI routinely shares information with our law enforcement partners in order to assist in protecting the communities they serve," the spokesperson said.

## Actor leaves extremely bizarre message on Instagram featuring apology to President Trump and QAnon just before killing himself

Actor Isaac Kappy committed suicide following a bizarre and rambling message on Instagram that included an apology to President Donald Trump and a group of conspiracy theorists.

Kappy, who once made headlines for reportedly choking Michael Jackson's daughter, Paris, during a 2018 party, also made news headlines for alleging that some celebrities and Hollywood figures were pedophiles.

**What are the details of his death?**

Police reported that Kappy, 42, forced himself off a bridge over a freeway on Monday near Flagstaff, Arizona.

According to the Arizona Daily Sun, Kappy died at the scene after leaping from the bridge and landing on the freeway below, where a vehicle struck him.

Prior to his death, Kappy performed small parts in movies like "Thor" and "Terminator: Salvation."

Authorities did not name a motive behind Kappy's apparent suicide.

### **What was in his Instagram post?**

In a nearly incoherent and rambling Instagram post, Kappy — whose mental health appeared to deteriorate significantly around the time of the 2018 incident involving Paris Jackson — apologized for being a bad man throughout his life.

A portion of his post, which the late actor appears to have shared Monday, said, "Over the course of the last week, through introspection that should have happened MANY years ago, I have come to some stark revelations about my character. It is a testament to my utter arrogance that these revelations had not come sooner."

"You see," he continued, "I believed myself to be a good guy. I HAVE NOT been a good guy."

Kappy pointed out that he used people throughout his life for money and had betrayed them and broken their trust to further himself.

"I have sold drugs," he admitted. "I have tax delinquencies. I have debts. I have abused my body with cigarettes, drugs, and alcohol."

The actor revealed that he abused his friends and family even when they were simply trying to love him.

"Earlier this week, I committed an act so flippantly, without thought, that will become synonymous with short sightedness and petty, vile greed, and in the end, has cost me everything," he admitted. It is unclear what incident Kappy is pointing toward in the post.

Kappy — who in 2018 accused several Hollywood figures such as actors Seth Green and Tom Hanks, and producer Steven Spielberg of being pedophiles —

also said in his letter that despite "outing the truth of Hollywood," he "did not REFLECT ON MY OWN TRUTHS AND MANY, MANY SHORTCOMINGS."

"While it is true I have spent many, many hours of research and disseminating information about bad actors, I have had SO LITTLE CARE for introspection of MY OWN actions," he later wrote. "While it's true I have outed many pedophiles that were former FRIENDS, I remained in their sphere for much longer than I should have, and attempted to gain from them AFTER I knew about their actions."

#### **What else?**

The actor went on and apologized to the "Q movement" — or QAnon, a pro-Trump 4Chan group that peddles many conspiracy theories, including that there is a deep state plot against President Trump — for sabotaging their work. You can read more about the group [here](#).

"Q says they give people enough rope to hang themselves, and I have hung myself," he wrote. "I have told people in the Trump administration that I am willing to admit to my many crimes in a public setting, and committed to execution, in a public setting."

"A nation cannot suffer its traitors, and I am no exception," Kappy added.

"To Jesus," he wrote, "I am sorry I have betrayed you AGAIN. ... Jesus, you offered so much, and instead of reveling in your wisdom, I used my attention on darkness."

"President Trump," he continued, "I have betrayed you and squandered good will, and now I shall forever be known for my actions."



Kappy went on to apologize to a plethora of others in the lengthy note, including former friends, family, and more.

"I will be using the remainder of my time on earth to atone for my transgressions, and to seek the light within, in others and myself," he concluded.

Kappy dated the note July 4, 2019, which he wrote "Return of the King" and "Return to THE LIGHT."

# Exclusive: FBI document warns conspiracy theories are a new domestic terrorism threat

The FBI for the first time has identified fringe conspiracy theories as a domestic terrorist threat, according to a previously unpublicized document obtained by Yahoo News. (Read the document below.)

The FBI intelligence bulletin from the bureau's Phoenix field office, dated May 30, 2019, describes "conspiracy theory-driven domestic extremists," as a growing threat, and notes that it is the first such report to do so. It lists a number of arrests, including some that haven't been publicized, related to violent incidents motivated by fringe beliefs.

The document specifically mentions QAnon, a shadowy network that believes in a deep state conspiracy against President Trump, and Pizzagate, the theory that a pedophile ring including Clinton associates was being run out of the basement of a Washington, D.C., pizza restaurant (which didn't actually have a basement).

"The FBI assesses these conspiracy theories very likely will emerge, spread, and evolve in the modern information marketplace, occasionally driving both groups and individual extremists to carry out criminal or violent acts," the document states. It also goes on to say the FBI believes conspiracy theory-driven extremists are likely to increase during the 2020 presidential election cycle.

The FBI said another factor driving the intensity of this threat is "the uncovering of real conspiracies or cover-ups involving illegal, harmful, or unconstitutional activities by government officials or leading political

figures.” The FBI does not specify which political leaders or which cover-ups it was referring to.

President Trump is mentioned by name briefly in the latest FBI document, which notes that the origins of QAnon is the conspiratorial belief that “Q,” allegedly a government official, “posts classified information online to reveal a covert effort, led by President Trump, to dismantle a conspiracy involving ‘deep state’ actors and global elites allegedly engaged in an international child sex trafficking ring.”

This recent intelligence bulletin comes as the FBI is facing pressure to explain who it considers an extremist, and how the government prosecutes domestic terrorists. In recent weeks the FBI director has addressed domestic terrorism multiple times but did not publicly mention this new conspiracy theorist threat.

The FBI is already under fire for its approach to domestic extremism. In a contentious hearing last week before the Senate Judiciary Committee, FBI Director Christopher Wray faced criticism from Democrats who said the bureau was not focusing enough on white supremacist violence. “The term ‘white supremacist,’ ‘white nationalist’ is not included in your statement to the committee when you talk about threats to America,” Sen. Richard Durbin, D-Ill., said. “There is a reference to racism, which I think probably was meant to include that, but nothing more specific.”

Wray told lawmakers the FBI had done away with separate categories for black identity extremists and white supremacists, and said the bureau was instead now focusing on “racially motivated” violence. But he added, “I will say that a majority of the domestic terrorism cases that we’ve investigated are motivated by some version of what you might call white supremacist violence.”

The FBI had faced mounting criticism for the term “black identity extremists,” after its use was revealed by Foreign Policy magazine in 2017. Critics pointed out that the term was an FBI invention based solely on race, since no group or even any specific individuals actually identify as black identity extremists.

In May, Michael C. McGarrity, the FBI’s assistant director of the counterterrorism division, told Congress the bureau now “classifies domestic terrorism threats into four main categories: racially motivated violent extremism, anti-government/anti-authority extremism, animal

rights/environmental extremism, and abortion extremism,” a term the bureau uses to classify both pro-choice and anti-abortion extremists.

The new focus on conspiracy theorists appears to fall under the broader category of anti-government extremism. “This is the first FBI product examining the threat from conspiracy theory-driven domestic extremists and provides a baseline for future intelligence products,” the document states.

The new category is different in that it focuses not on racial motivations, but on violence based specifically on beliefs that, in the words of the FBI document, “attempt to explain events or circumstances as the result of a group of actors working in secret to benefit themselves at the expense of

others” and are “usually at odds with official or prevailing explanations of events.”

The FBI acknowledges conspiracy theory-driven violence is not new, but says it’s gotten worse with advances in technology combined with an increasingly partisan political landscape in the lead-up to the 2020 presidential election. “The advent of the Internet and social media has enabled promoters of conspiracy theories to produce and share greater volumes of material via online platforms that larger audiences of consumers can quickly and easily access,” the document says.

The bulletin says it is intended to provide guidance and “inform discussions within law enforcement as they relate to potentially harmful conspiracy theories and domestic extremism.”

The FBI Phoenix field office referred Yahoo News to the bureau’s national press office, which provided a written statement.

“While our standard practice is to not comment on specific intelligence products, the FBI routinely shares information with our law enforcement partners in order to assist in protecting the communities they serve,” the FBI said.

In its statement, the FBI also said it can “never initiate an investigation based solely on First Amendment protected activity. As with all of our investigations, the FBI can never monitor a website or a social media platform without probable cause.”

The Department of Homeland Security, which has also been involved in monitoring domestic extremism, did not return or acknowledge emails and phone requests for comment.

While not all conspiracy theories are deadly, those identified in the FBI’s 15-page report led to either attempted or successfully carried-out violent attacks. For example, the Pizzagate conspiracy led a 28-year-old man to invade a Washington, D.C., restaurant to rescue the children he believed were being kept there, and fire an assault-style weapon inside.

The FBI document also cites an unnamed California man who was arrested on Dec. 19, 2018, after being found with what appeared to be bomb-making materials in his car. The man allegedly was planning “blow up a satanic temple monument” in the Capitol rotunda in Springfield, Ill., to “make Americans aware of Pizzagate and the New World Order, who were dismantling society,” the document says.

Historian David Garrow, the author of a Pulitzer Prize-winning biography of Martin Luther King Jr. who has worked extensively with FBI archives, raised doubts to Yahoo News about the memo. He says the FBI’s default assumption is that violence is motivated by ideological beliefs rather than mental illness. “The guy who shot up the pizza place in D.C.: Do we think of him as a right-wing activist, or insane?” Garrow asked.

Garrow was similarly critical of the FBI's use of the term "black identity extremists" and related attempts to ascribe incidents like the 2016 shooting of six police officers in Baton Rouge, La., to black radicalism. He said the shooter, Gavin Long, had a history of mental health problems. "The bureau's presumption — the mindset — is to see ideological motives where most of the rest of us see individual nuttiness," he said.

Identifying conspiracy theories as a threat could be a political lightning rod, since President Trump has been accused of promulgating some of them, with his frequent references to a deep state and his praise in 2015 for Alex Jones, who runs the conspiracy site InfoWars. While the FBI intelligence bulletin does not mention Jones or InfoWars by name, it does mention some of the conspiracy theories frequently associated with the far-right radio host, in particular the concept of the New World Order.

Jones claimed the Sandy Hook Elementary School shooting, in which 26 children were killed, was a hoax, a false flag operation intended as a pretext for the government to seize or outlaw firearms. The families of a number of victims have sued Jones for defamation, saying his conspiracy-mongering contributed to death threats and online abuse they have received.

While Trump has never endorsed Sandy Hook denialism, he was almost up until the 2016 election the most high-profile promoter of the birther conspiracy that claimed former President Barack Obama was not born in the United States. He later dropped his claim, and deflected criticism by pointing the finger at Hillary Clinton. He said her campaign had given birth to the conspiracy, and Trump "finished it."

There is no evidence that Clinton started the birther conspiracy.

Joe Uscinski, an associate professor of political science at the University of Miami, whose work on conspiracy theories is cited in the intelligence bulletin, said there's no data suggesting conspiracy theories are any more widespread now than in the past. "There is absolutely no evidence that people are more conspiratorial now," says Uscinski, after Yahoo News described the bulletin to him. "They may be, but there is not strong evidence showing this."

It's not that people are becoming more conspiratorial, says Uscinski, but conspiracies are simply getting more media attention.

"We are looking back at the past with very rosy hindsight to forget our beliefs, pre-internet, in JFK [assassination] conspiracy theories and Red scares. My gosh, we have conspiracy theories about the king [of England]

written into the Declaration of Independence,” he said, referencing claims that the king was planning to establish tyranny over the American colonies.

It’s not that conspiracy theorists are growing in number, Uscinski argues, but that media coverage of those conspiracies has grown. “For most of the last 50 years, 60 to 80 percent of the country believe in some form of JFK conspiracy theory,” he said. “They’re obviously not all extremist.”

Conspiracy theories, including Russia’s role in creating and promoting them, attracted widespread attention during the 2016 presidential election when they crossed over from Internet chat groups to mainstream news coverage. Yahoo News’s “Conspiracyland” podcast recently revealed that Russia’s foreign intelligence service was the origin of a hoax report that tied the murder of Seth Rich, a Democratic National Committee staffer, to Hillary Clinton.

Among the violent conspiracy theories cited in the May FBI document is one involving a man who thought Transportation Security Administration agents were part of a New World Order. Another focused on the High Frequency Active Auroral Research Program (HAARP), a government-funded facility in Alaska that has been linked to everything from death beams to mind control. The two men arrested in connection with HAARP were “stockpiling weapons, ammunition and other tactical gear in preparation to attack” the facility, believing it was being used “to control the weather and prevent humans from talking to God.”

Nate Snyder, who served as a Department of Homeland Security counterterrorism official during the Obama administration, said that the FBI appears to be applying the same radicalization analysis it employs against foreign terrorism, like the Islamic State group, which has recruited followers in the United States.

“The domestic violent extremists cited in the bulletin are using the same playbook that groups like ISIS and al-Qaida have used to inspire, recruit

and carry out attacks,” said Snyder, after reviewing a copy of the bulletin provided by Yahoo News. “You put out a bulletin and say this is the content they’re looking at — and it’s some guy saying he’s a religious cleric or philosopher — and then you look at the content, videos on YouTube, etc., that they are pushing and show how people in the U.S. might be radicalized by that content.”

Though the FBI document focuses on ideological motivations, FBI Director Wray, in his testimony last week, asserted that the FBI is concerned only with violence, not people’s beliefs. The FBI doesn’t “investigate ideology, no matter how repugnant,” he told lawmakers. “We investigate violence. And any extremist ideology, when it turns to violence, we are all over it. ... In the first three quarters of this year, we’ve had more domestic terrorism arrests than the prior year, and it’s about the same number of arrests as we have on the international terrorism side.”

Yet the proliferation of the extremist categories concerns Michael German, a former FBI agent and now a fellow with the Brennan Center for Justice’s Liberty & National Security program. “It’s part of the radicalization theory the FBI has promoted despite empirical studies that show it’s bogus,” he said.

German says this new category is a continuing part of FBI overreach. “They like the radicalization theory because it justifies mass surveillance,” he said. “If we know everyone who will do harm is coming from this particular community, mass surveillance is important. We keep broadening the number of communities we include in extremist categories.”

For Garrow, the historian, the FBI’s expansive definition has its roots in bureau paranoia that dates back decades. “I think it’s their starting point,” he said. “This goes all the way back to the Hoover era without question. They see ideology as a central motivating factor in human life, and they don’t see mental health issues as a major factor.”

Yet trying to label a specific belief system as prone to violence is problematic, he said.

“I don’t think most of us would do a good job in predicting what sort of wacky information could lead someone to violence, or not lead anyone to violence,” Garrow said. “Pizzagate would be a great example of that.”

While Trump may not be supportive of labeling a group like QAnon, which sees him as a hero, as extremist, he's in favor of broadening the number of organizations that are labeled as violent extremists, at least on the left. On Saturday, President Trump tweeted that Antifa, a far-left movement opposed to what it considers fascism, should be labeled a terrorist organization.

Snyder, the former Homeland Security official, agrees that conspiracy theories may in fact inspire violence and be a threat, but questions what the government is going to do about it.

He notes that at the Department of Homeland Security, "nearly all, if not all, the intelligence analysts focusing on domestic extremist groups" were eliminated under the Trump administration. "There is no one there doing this," he said.

Fortunately, Q has a solution to the Trump rally ban: buy more QAnon T-shirts.

QAnon conspiracy theorists have begun sneaking their QAnon shirts into Trump rallies amid reports that people wearing the shirts have been turned away by people they claim are Secret Service officers staffing Trump events.

QAnon is founded on a series of anonymous clues posted online by a person named “Q” that purport to show a secret world where Trump is engaged in endless battle with a pedophile cabal of high-ranking Democrats and where Trump’s foes will soon be banished to Gitmo. It is an inherently ludicrous idea but one that’s managed to gain a ton of traction through Trump rallies, where attendees regularly show up with Q shirts and signs.

Indeed, the conspiracy theory jumped into the mainstream in July, when a number of people with QAnon shirts and signs were shown on TV at a Trump rally in Florida. Other QAnon supporters who get caught on camera at Trump rallies have earned cryptic shout-outs from Q, and believers in the theory scrutinize Trump’s hand gestures at rallies to claim he’s pointing to QAnon believers.

But now QAnon fans hoping for a viral moment of their own say they’re being told they can’t wear QAnon-related shirts to the Trump rallies. On Monday, a QAnon supporter trying to attend a rally the president was holding in Tennessee claimed on Twitter that a Secret Service agent told her that “Q” shirts weren’t allowed at the rally.

But Thornburg still managed to show her QAnon support.

"I ended up holding the shirt up high and waving it during the rally so it could be seen," Thornburg told The Daily Beast.

The Secret Service didn't respond to requests for comment.

Other QAnon believers have started to get more creative, with one covering a shirt with a jacket in an attempt to get around the rally ban.

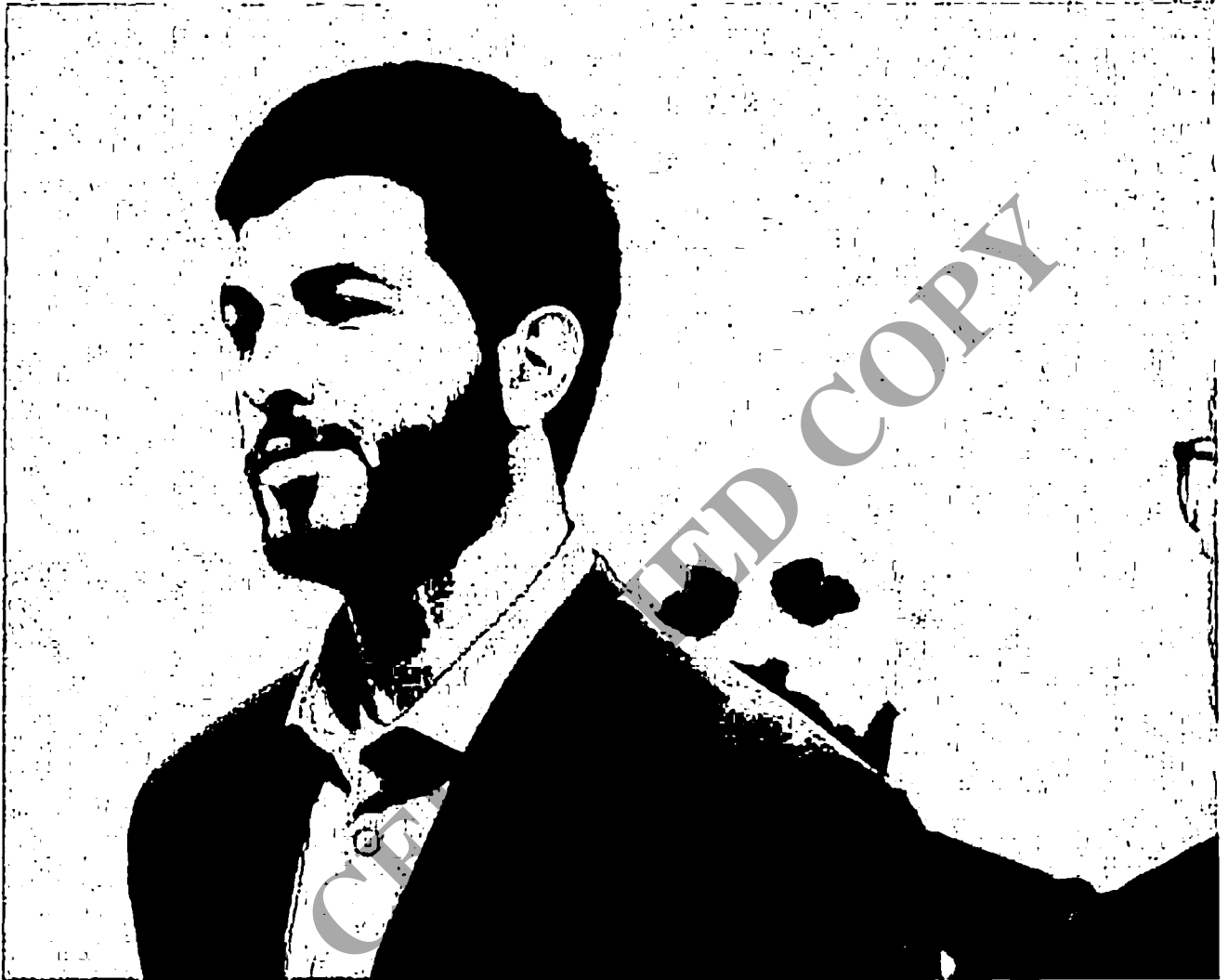

The man who is accused of fatally shooting a New York City mob boss in a brazen crime that shocked observers and the law enforcement community allegedly thought he had the protection of President Trump and was trying to

arrest the mob boss as part of a battle against the "Deep State," new court documents claim.

Anthony Comello is charged with the murder of Francesco "Franky Boy" Cali, the reputed head of the infamous Gambino crime family.

Authorities initially feared a possible mob war in the wake of Cali's shooting death in March, but later Comello, who has no known mob ties, was identified as the suspect. He has entered a not guilty plea to murder and weapons possession charges.

In new court documents submitted Friday, Comello's defense attorney details how his client -- who he is arguing suffers from mental defect -- allegedly was a believer in the "conspiratorial fringe right-wing political group" QAnon.

QAnon has found its way out of the recesses of the internet with references on Alex Jones' "InfoWars" and from celebrities like Roseanne Barr. Trump supporters were also spotted wearing "Q" T-shirts at rallies in June 2018. Then-press secretary Sarah Sanders said the "president condemns and denounces any group that would incite violence against another individual" in response to a question about QAnon.

Comello's family "began to notice changes in his personality" following the presidential election in 2016, noting that he took an interest in politics, which was "something he had not previously been involved in," the court document states.

Comello allegedly "became increasingly vocal about his support for QAnon," about a month-and-a-half before Cali's murder, the documents state.

"But Mr. Comello's support for QAnon went beyond mere participation in a radical political organization, it evolved into a delusional obsession," the legal memorandum states.

According to the memo, QAnon follows the "postings of an individual (or group of individuals) who write using the pseudonym 'Q'." Devotees believe that there are people working in the so-called "Deep State" who are trying to ruin America and President Donald Trump and his supporters are battling against them.

"As part of his delusion, the defendant believed that he had been given secret knowledge about the Deep State, and that Q was communicating directly with him so that the defendant could play a grand role in the conflict to save the American way of life. Because of his self-perceived status in QAnon, Mr. Comello became certain that he was enjoying the protection of President Trump himself, and that he had the president's full support," the court document states.

His attorney's document notes how Comello tried to make citizen's arrests of three prominent politicians, all of whom are Democrats and vocal critics of Trump -- New York City mayor Bill de Blasio, and Representatives Maxine Waters and Adam Schiff. All three of those citizen's arrests, in February 2019 or shortly after, were unsuccessful.

In the de Blasio case, the mayor's security detail thwarted him and in the case with the members of Congress, U.S. Marshals did not help him, which

Comello allegedly believed they would. His lawyer said Comello believed de Blasio was guilty of "election fraud" and the two members of Congress were "guilty of breaking the law."

Comello allegedly intended to perform another attempted citizen's arrest when he went to confront Cali as well, but the incident escalated, according to the court document.

"In addition to politicians and celebrities, Mr. Comello concluded that the Deep State also includes individuals associated with organized crime. He ardently believed that Francesco Cali, a boss in the Gambino Crime Family, was a prominent member of the Deep State, and, accordingly, an appropriate target for a citizen's arrest," the memorandum states.

The documents detail how Comello drove to Cali's Staten Island home on March 13 and "struck" the mob boss's car which was parked outside of the residence.

The noise apparently prompted Cali to leave the house and speak to Comello about the damage to the car.

"While the two men were standing near their respective vehicles, Mr. Comello informed Mr. Cali of his true intention to effect a citizen's arrest, and ordered Mr. Cali to submit to detention," the document states, adding that Comello "brought handcuffs with him, and planned to restrain Mr. Cali and bring him to the appropriate authorities to answer for the criminal actions which Mr. Comello believed he had taken part in."

"After a heated exchange, Mr. Cali made a furtive action with his hand and Mr. Comello became afraid for his life. He reached into his vehicle, withdrew his gun, and shot Mr. Cali in self-defense," the document states.

Comello's defense attorney has already submitted a notice of intent to show evidence of mental disease or defect, the documents state.

"Had Mr. Comello simply intended to lure Mr. Cali out of his house and murder him, there would have been no need to bring any elements of restraint," the document states. "The presence of these handcuffs demonstrates that Mr. Comello was actually planning to effect a citizen's arrest on Mr. Cali, rather than shoot him."

A judge denied Comello's attorney's request for bail in May.

The documents were filed in connection to a request for specific pieces of evidence to be submitted as discovery, and the next court appearance is slated for Aug. 13.

COMPLAINT FOR DEFAMATION

Plaintiff, Gabe Hoffman, (hereinafter "HOFFMAN"), individually, by and through his undersigned counsel, sues Thomas Schoenberger, (hereinafter "SCHOENBERGER"), individually, and alleges:

PARTIES, JURISDICTION AND VENUE

1. Plaintiff HOFFMAN is an individual and is a resident of Palm Beach County, Florida.
2. HOFFMAN is the founder of Accipiter Capital Management, LLC, ("Company") which is a hedge fund, located in Palm Beach County, Florida.
3. HOFFMAN is a highly respected and well known investment manager that regularly appears on television addressing a wide range of business issues and financial investments.
4. HOFFMAN'S livelihood and success are inextricably connected to his unassailable integrity and hard-won relationships to his investors.

5. HOFFMAN maintains relationships with prominent and well-known individuals in the financial markets and financial management industry and relies on his excellent reputation and unassailable integrity to attract and maintain his investment capital for his Company's operations.

6. HOFFMAN is also a well-respected philanthropist, who solely funded and produced the groundbreaking documentary film exposing child sex abuse in Hollywood, "An Open Secret". "An Open Secret" has generated extensive worldwide press and critical acclaim, by many major publications, television, and widely viewed forms of alternative media. Two years ago, HOFFMAN released his \$1.5 million budget documentary film FREE to the public on Vimeo. The film immediately went viral, has been watched by many millions of people worldwide, and has been publicly endorsed by numerous film critics, celebrities, and many other notable people. Millions of people have seen HOFFMAN in live interviews, or in print / internet media worldwide, discussing his film.

7. Defendant SCHOENBERGER is a notorious Internet "troll" with a whereabouts in California. He has engaged in a continuous bullying campaign against HOFFMAN and numerous other individuals through the Internet and other social platforms.

8. SCHOENBERGER has a long criminal record. On information and belief, he has at least one stalking conviction and is currently on probation for his crimes.

9. Defendant SCHOENBERGER has, on information and belief, engaged in defamatory conduct against other individuals. It is believed that there are numerous other orders of protection granted against SCHOENBERGER.

10. SCHOENBERGER, on information and belief, had numerous YouTube and Twitter accounts suspended, due to his defamatory "bullying" of several individuals. Despite these

suspensions, SCHOENBERGER creates “replacement” accounts and continues his “bullying” against the stated Terms of Service for both YouTube and Twitter. SCHOENBERGER’s current confirmed twitter accounts are @RobertP01038274, @watchingwtrboil, and @ExpInfiltrators.

11. Jurisdiction and venue is proper in this Court because the amount in controversy exceeds \$15,000 and the operative facts for the cause of action relate to HOFFMAN’S reputation as hedge fund manager in Palm Beach County, Florida.

12. All conditions precedent to the bringing of this action have occurred, been performed or excused, or would have been futile.

**COUNT I: DEFAMATION**

13. HOFFMAN re-alleges and incorporates paragraphs 1-12 above as if more fully stated.

14. SCHOENBERGER has promoted and coordinated a defamation campaign against HOFFMAN. SCHOENBERGER published reprehensible and defamatory statements against HOFFMAN on the social media platform Twitter, YouTube television and through a voicemail to a third party.

15. On information and belief, SCHOENBERGER has encouraged other individuals to defame and harass HOFFMAN, including, but not limited to, the following individuals: Alessandro Valerin (a/k/a Alessandro Castellan, a/k/a Alessandro Valerin Castellan) (@LouderThanLove1 and @totaldisclosure1), Dean Fougere (@ImperatorTruth and YouTube: Titus Frost & Titus Frost 1984 channels), Steve Outtrim (@steveouttrim aka cryptobeastburners.me), Julio Cesareo Jacques (@infinitytozero and YouTube: An All American Cartel LLC) and Cory Daniel (@ThePhoenixEnig1 and Website: <https://thephoenixenigma.com/>).

16. Over the past several months, SCHOENBERGER has published over one hundred defamatory statements against HOFFMAN and has promoted and/or shared their defamation of HOFFMAN on his YouTube and Twitter accounts repeatedly. Set forth herein, is a small sample of SCHOENBERGER's defamatory and harassing comments against HOFFMAN.

17. SCHOENBERGER stated that HOFFMAN is involved in an entertainment industry pedophile ring and provides cover for Hollywood moguls to express their basest pedophile desires. Specifically, SCHOENBERGER stated that "Hollywood has a century old tradition of pedophilia, and that includes, Louis B. Mayer, that includes, Charlie Chaplin, it's how the engine runs. And how do they keep it up? Gatekeepers like Gabe Hoffman. Gabe will point hysterically to seven pedophiles while providing cover for seven hundred more."

18. SCHOENBERGER, as @DBRGLOING, stated that "[t]his is TS. The goal of MAGA Coalition is the same goal as Gabe Hoffman, Defango, and Mister priest, namely the continued cover up regarding a massive culture of pedophilia in Hollywood."

19. SCHOENBERGER made numerous defamatory statements regarding HOFFMAN, related to the suicide death of Isaac Kappy. Isaac Kappy was a former Hollywood actor, and publicly ardent believers in the "QAnon" conspiracy theory, who committed suicide in May. According to local news reports, as well as reports by law enforcement, around 7:30 A.M., in broad daylight, with many witnesses, Kappy caused himself to fall off a highway overpass. SCHOENBERGER stated on twitter that "Gabe Hoffman, that vertically challenged congenital liar is exposed as a man trying to stop an investigation into his role in Isaac Kappy's death."

20. SCHOENBERGER stated on twitter that "Gabe does not like the fact that HE is now the focus suspect in Isaac Kappy's death. Remain resolute. Gabe Hoffman is acting VERY

MUCH LIKE A MAN TRYING TO DISTRACT INVESTIGATORS FROM LOOKING AT HIM!”

21. SCHOENBERGER left a voicemail for third party, that was published on YouTube television, stating that HOFFMAN was being investigated by the Federal Bureau of Investigation for the murder of Isaac Kappy.

22. SCHOENBERGER stated that “[t]he F.B.I is in full bore investigation, they’re [F.B.I.] looking at Gabe, I know a lot more than I’m saying . . .they’re [F.B.I] going in full bore, they’re not giving me a whole bunch of information, but, what I do know, is the investigation is a murder investigation, and Isaac Kappy did not kill himself.”

23. SCHOENBERGER published on the website of Steve Outtrim that HOFFMAN was “unlocked from Kappy’s dead man’s switch.” On information and belief, SCHOENBERGER promoted the “Kappy claims” against HOFFMAN through Dean Fougere on his YouTube channel.

24. On October 19, from his Twitter account @RobertP01038274, SCHOENBERGER replied to a Tweet about Isaac Kappy to six accounts in total: <https://twitter.com/RobertP01038274/status/1185689298630131712?s=20>, <https://tweetstamp.org/1185689298630131712> (“So Gabe had him killed and hired Defango, Lestat and Sharkbelly/Brett to cover it up”).

25. On October 14, SCHOENBERGER made a video sharing defamatory content posted by Alessandro Valerin a/k/a Alessandro Castellon a/k/a Alessandro Valerin Castellon (@LouderThanLove1 and @totaldisclosure1) describing the video in the following manner: “Isaac Kappy was murdered. Please help. Tell us what you know. You can be anonymous. The people loved Isaac and it’s the People who will solve his murder!” The Twitter link used was

<https://twitter.com/LouderThanLove1> ("I'm compiling horror and harassment stories involving Gabe Hoffman from An Open Secret. The guy has TONS of skeletons in his closet that I've been digging up. He's basically a gatekeeper and cover upper for the crimes of people like Steven Spielberg, Hillary and Bill Clinton, John Podesta, David Geffen, etc. He is also a main suspect in participating in the conspiracy to murder Isaac Kappy and the subsequent cover up.")

26. SCHOENBERGER has continually harassed HOFFMAN through the internet, and has even posted a picture of HOFFMAN's home and his home address through the Twitter account @ExpInfiltrators around 1 A.M. East Coast Time, October 24<sup>th</sup>, 2019. SCHOENBERGER has also defamed HOFFMAN through various Twitter accounts @DBRGLONG (a/k/a @solus 777) and, on information and belief, through the Twitter account @RobertP01038274 and @watchingwtrboil.

27. SCHOENBERGER'S published statements are false.

28. SCHOENBERGER knew these statements were false and negligently made these statements anyway.

29. HOFFMAN has been damaged by these statements.

30. SCHOENBERGER'S statements were completely defamatory and calculated to damage HOFFMAN'S reputation as a well-respected financial manager.

WHEREFORE, HOFFMAN demands judgment against SCHOENBERGER for damages, awarding interest and attorneys' fees, and costs and any other relief that may be just or necessary under the circumstances.

**DEMAND FOR JURY TRIAL**

The Plaintiff demands a trial by jury on all issues triable as a matter of right.
