ORDER ON MOTION TO WITHDRAW AS COUNSEL FOR PLAINTIFF


THIS CAUSE having come before the Court for consideration upon the Motion to Withdraw as Counsel for Plaintiff (filed 3/29/2021 Filing#123908388), and the Court, having reviewed the subject Motion and being otherwise fully advised in the premises, it is

ORDERED AND ADJUDGED as follows:

1. The referenced Motion to Withdraw as Counsel for Plaintiff is GRANTED. Dennis S. Klein, Esq. and Kelley Kronenberg are hereby relieved of all duties as counsel for Plaintiff in this matter.
2. Kelley Kronenberg is directed to mail and email a copy of this Order to Plaintiff.
3. Within 30 days from the date of this order, Plaintiff shall either: Retain new counsel and have that counsel file a written appearance with the Clerk of the Court; OR Plaintiff shall file a written notice with the Clerk of the Court advising that Plaintiff will represent himself.
4. Failure to comply with the preceding paragraph will create a presumption that Plaintiff no longer wishes to participate in this lawsuit and the Court may sua sponte or on motion of opposing party impose sanctions against Plaintiff. Sanctions may include the imposition of fees and costs, striking of pleadings, entry of default, and dismissal with prejudice.
5. In the interim, Plaintiff is required to comply with orders/notices requiring Plaintiff's appearance in court.
6. Plaintiff may be served at the following mailing and email address: **12210 Banyan Road, North Palm Beach, FL 33408 – ghoff1995@gmail.com**. Plaintiff is responsible for updating the address by filing a notice of new address with the Clerk of the Court and providing a

copy to opposing counsel. Failure to update the address shall constitute a waiver of any defenses due to lack of notice.
